

FEDERAL ACQUISITION REGULATION (FAR) AND DEFENSE FEDERAL ACQUISITION REGULATION SUPPLEMENT
(DFARS) FLOWDOWN PROVISIONS

Subject to the qualifications below, the following FAR and DFARS clauses referenced are incorporated herein with the same force and effect as if they were given in full text. The effective version of each provision shall be the same version as that which appears in Corfin's contract under which this order is placed. In all clauses listed herein, the terms "Government", "Contracting Officer" and "Contractor" shall be revised to suitably identify the contracting parties herein and effect the proper intent of the provision.

DFARS 252.223-7008 PROHIBITION OF HEXAVALENT CHROMIUM (Applies if this order is for maintenance and repair services, or construction materials)

DFAR 252.225-7008 RESTRICTION ON ACQUISITION OF SPECIALTY METALS

DFARS 252.225-7009 RESTRICTION ON ACQUISITION OF CERTAIN ARTICLES CONTAINING SPECIALTY METALS (Applies if the order contains specialty metals.)

DFARS 252.225-7048 EXPORT-CONTROLLED ITEMS

DFARS 252.246-7003 NOTIFICATION OF POTENTIAL SAFETY ISSUES (Applies if this order is for (i) parts identified as critical safety items; (ii) systems and subsystems, assemblies, and subassemblies integral to a system; or (iii) repair, maintenance, logistics support, or overhaul services for systems and subsystems, assemblies, subassemblies, and parts integral to a system.)
